2022 Instructions for Schedule J

Income Averaging for Farmers and Fishermen

Use Schedule J (Form 1040) to elect to figure your 2022 income tax by averaging, over the previous 3 years (base years), all or part of your 2022 taxable income from your trade or business of farming or fishing. This election may give you a lower tax if your 2022 income from farming or fishing is high and your taxable income for 1 or more of the 3 prior years was low.

In order to qualify for this election, you aren't required to have been in the business of farming or fishing during any of the base years.

You may elect to average farming or fishing income even if your filing status wasn't the same in the election year and the base years.

This election doesn't apply when figuring your alternative minimum tax on Form 6251. Also, you don't have to refigure, because of this election, the tax liability of any minor child who was required to use your tax rates in the prior years.

Section references are to the Internal Revenue Code unless otherwise noted.

General Instructions

Prior Year Tax Returns

You may need copies of your original or amended income tax returns for 2019, 2020, and 2021 to figure your tax on Schedule J.

If you need copies of your tax returns, use Form 4506. There is a fee for each return requested. See Form 4506 for the fee amount. If your main home, principal place of business, or tax records are located in a federally declared disaster area, this fee will be waived. If you want a free transcript of your tax return or account, use Form 4506-T. See your Instructions for Form 1040 to find out how to get these forms.

Keep a copy of your 2022 income tax return to use for income averaging in 2023, 2024, or 2025.

Note. Tax years 2021 and prior referred to the term "Qualifying widow(er)." For tax years beginning in 2022, the term will be referred to as "Qualifying

surviving spouse." We will match the term to the year of use.

Definitions

Farming business. A farming business is the trade or business of cultivating land or raising or harvesting any agricultural or horticultural commodity. This includes:

- 1. Operating a nursery or sod farm;
- 2. Raising or harvesting of trees bearing fruits, nuts, or other crops;
- 3. Raising ornamental trees (but not evergreen trees that are more than 6 years old when severed from the roots);
- 4. Raising, shearing, feeding, caring for, training, and managing animals; and
- 5. Leasing land to a tenant engaged in a farming business, but only if the lease payments are (a) based on a share of the tenant's production (not a fixed amount), and (b) determined under a written agreement entered into before the tenant begins significant activities on the land.
 - A farming business doesn't include:
- Contract harvesting of an agricultural or horticultural commodity grown or raised by someone else, or
- Merely buying or reselling plants or animals grown or raised by someone else.

Fishing business. A fishing business is the trade or business of fishing in which the fish harvested, either in whole or in part, are intended to enter commerce or

enter commerce through sale, barter, or trade. This includes:

- 1. The catching, taking, or harvesting of fish;
- 2. The attempted catching, taking, or harvesting of fish;
- 3. Any other activity that can reasonably be expected to result in the catching, taking, or harvesting of fish;
- 4. Any operations at sea in support of, or in preparation for, any activity described in (1) through (3) above;
- 5. Leasing a fishing vessel, but only if the lease payments are (a) based on a share of the catch (or a share of the proceeds from the sale of the catch) from the lessee's use of the vessel in a fishing business (not a fixed payment), and (b) determined under a written lease entered into before the lessee begins any significant fishing activities resulting in the catch; and
- 6. Compensation as a crew member on a vessel engaged in a fishing business, but only if the compensation is based on a share of the catch (or a share of the proceeds from the sale of the catch).

The word "fish" means finfish, mollusks, crustaceans, and all other forms of marine animal and plant life other than marine mammals and birds.

A fishing business doesn't include any scientific research activity conducted by a scientific research vessel.

Specific Instructions

Line 2a

Elected Farm Income

To figure your elected farm income, first figure your taxable income from farming or fishing. This includes all income, gains, losses, and deductions attributable to your farming or fishing business. If you conduct both farming and fishing businesses, you must figure your elected farm income by combining income, gains, losses, and deductions attributable to your farming and fishing businesses.

Elected farm income also includes any gain or loss from the sale or other disposition of property regularly used in your farming or fishing business for a substantial period of time. However, if such gain or loss is realized after cessation of the farming or fishing business, the gain or loss is treated as attributable to a farming or fishing business only if the property is sold within a reasonable time after cessation of the farming or fishing business. A sale or other disposition within 1 year of the cessation is considered to be within a reasonable time

Elected farm income doesn't include income, gain, or loss from the sale or other disposition of land or from the sale of development rights, grazing rights, and other similar rights.

You should find your income, gains, losses, and deductions from farming or fishing reported on different tax forms, such as:

- 2022 Form 1040 or 1040-SR, or Form 1040-NR, line 1a, income from wages and other compensation you received (a) as a shareholder in an S corporation engaged in a farming or fishing business, or (b) as a crew member on a vessel engaged in a fishing business (but see *Fishing business*, earlier);
- 2022 Schedule 1 (Form 1040), line 15, deductible part of self-employment tax, but only to the extent that de-

duction is attributable to your farming or fishing business;

- 2022 Form 1040, 1040-SR, or 1040-NR, line 15, CCF reduction, except to the extent that any earnings (without regard to the carryback of any net operating or net capital loss) from the operation of agreement vessels in the fisheries of the United States or in the foreign or domestic commerce of the United States aren't attributable to your fishing business;
 - Schedule C;
 - Schedule D;
 - Schedule E, Part II;
 - Schedule F;
 - Form 4797;
 - Form 4835;
- Form 8903, Domestic Production Activities Deduction, but only to the extent that deduction is attributable to your farming or fishing business; and
 - Form 8949.

Your elected farm income is the amount of your taxable income from farming or fishing that you elect to include on line 2a.



You don't have to include all of your taxable income from farming or fishing on line 2a. It may

be to your advantage to include less than the entire amount, depending on how the amount you include on line 2a affects your tax bracket for the current and prior 3 tax years.

The excess farm loss limitation rules don't apply for tax years beginning after 2017 and before 2029. The excess farm loss limitation rules are suspended during those years and replaced by the excess business loss limitation rules for tax years beginning after 2020 and before 2029. The at-risk limits and the passive activity limits are applied before calculating the amount of any excess business loss. The amount of any excess business loss allocable to your farming or fishing business(es) is not used in calculating the amount of your elected farm income. See generally the Instructions for Schedule F (Form 1040) and Form 461.

Your elected farm income can't exceed your taxable income.

Lines 2b and 2c

Complete lines 2b and 2c if the amount of your elected farm income on line 2a

includes net capital gain. Net capital gain is the excess, if any, of net long-term capital gain over net short-term capital loss.

Line 2b. Enter on line 2b the portion of your elected farm income on line 2a treated as a net capital gain. The amount you enter on line 2b can't exceed the smaller of your total net capital gain or the net capital gain attributable to your farming or fishing business.

Line 2c. Enter on line 2c the **smaller** of line 2b or the unrecaptured section 1250 gain attributable to your farming or fishing business, if any.

Line 4

Figure the tax on the amount on line 3 using:

- The 2022 Tax Table, Tax Computation Worksheet, or Qualified Dividends and Capital Gain Tax Worksheet from the 2022 Instructions for Form 1040 or the 2022 Instructions for Form 1040-NR:
- The 2022 Foreign Earned Income Tax Worksheet from the 2022 Instructions for Form 1040; or
- The Schedule D Tax Worksheet in the 2022 Instructions for Schedule D.

Enter the tax on line 4.

Line 5

If you used Schedule J to figure your tax for:

- 2021 (that is, you entered the amount from the 2021 Schedule J, line 23, on your 2021 Form 1040, 1040-SR, or Form 1040-NR, line 16; or on your 2021 Form 1040-X, line 6), enter on line 5 the amount from your 2021 Schedule J, line 11;
- 2020 but not 2021, enter on line 5 the amount from your 2020 Schedule J, line 15; or
- 2019 but not 2020 or 2021, enter on line 5 the amount from your 2019 Schedule J, line 3.

If you figured your tax for 2019, 2020, and 2021 without using Schedule J, enter on line 5 the taxable income from your 2019 tax return (or as previously adjusted by the IRS, or corrected on an amended return). But if that amount is zero or less, complete the 2019 Taxable Income Worksheet to figure the amount to enter on line 5.

If you didn't file a tax return for 2019, use the amount you would have reported as your taxable income had you been required to file a tax return. Be sure to keep all your records for 2019 for at least 3 years after April 18, 2023 (or the date you file your 2022 tax return, if later).

Instructions for 2019 Taxable Income Worksheet

Line 2. Any net capital loss deduction on your 2019 Schedule D. line 21, isn't allowed for income averaging purposes to the extent it didn't reduce your capital loss carryover to 2020. This could happen if the taxable income-shown on your 2019 Form 1040, line 11b, your 2019 Form 1040-NR-EZ, line 14, or your 2019 Form 1040-NR, line 41 (or as previously adjusted)—was less than zero. Enter on line 2 the amount by which your 2019 capital loss carryover to 2020 (the sum of your short- and long-term capital loss carryovers) exceeds the excess of the loss on your 2019 Schedule D, line 16, over the loss on your 2019 Schedule D, line 21. If you had any net operating loss (NOL) carrybacks to 2019, be sure you refigured your 2019 capital loss carryover to 2020.

Line 3. If you had an NOL for 2019, enter the amount of that NOL from the 2019 Form 1045, Schedule A, line 25, you filed with Form 1045 or Form 1040X. If you didn't have an NOL for 2019, enter the portion, if any, of the

NOL carryovers and carrybacks to 2019 that weren't used in 2019 and were carried to years after 2019.

Example. A farmer, who is single, didn't use income averaging for 2019, 2020, or 2021. For 2022, the farmer has \$18,000 of elected farm income on Schedule J, line 2a. The taxable income on the farmer's 2019 Form 1040, line 11b, is \$850. However, the farmer had a \$14,500 NOL for 2020, \$9,000 of which was remaining to carry to 2019 after the NOL was carried back to 2018. To complete line 1 of the 2019 Taxable Income Worksheet, the farmer combines the \$9,000 NOL deduction with the \$850 from the farmer's 2019 Form 1040, line 11b. The result is a negative \$8,150, the farmer's 2019 taxable income, which the farmer enters as a positive amount on line 1 of the 2019 Taxable Income Worksheet.

When the farmer filed the 2019 tax return, the farmer had a \$3,000 net capital loss deduction on Schedule D, line 21 (which was also entered on Form 1040, line 6); a \$7,000 loss on Schedule D, line 16; and a \$4,000 capital loss carryover to 2020. However, when the farmer carried back the 2020 NOL (\$9,000 of which was carried to 2019), the farmer refigured the 2019 capital loss carryover to 2020 as \$7,000. The farmer adds the \$3,000 from Schedule D, line 21, and the \$7,000 capital loss carryover. The farmer subtracts from the \$10,000 result the \$7,000 loss on the Schedule D. line 16, and enters \$3,000 on line 2 of the worksheet.

The farmer had \$850 of taxable income in 2019 that reduced the 2020 NOL carryback. The \$3,000 net capital loss deduction reduced the amount of the 2020 NOL carryback. As a result, only \$5,150 (\$9,000 - \$850 - \$3,000 =\$5,150) was available to carry to 2021 and later years, as shown on the farmer's 2020 Form 1045, Schedule B, line 10. The farmer enters the \$5.150 on line 3 of the worksheet, and \$8,150 (\$5,150 plus the \$3,000 line 2 amount) on line 4. The farmer then subtracts the \$8.150 from the \$8,150 on line 1 and enters the result, \$0, on line 5 of the worksheet. The farmer enters a negative \$0 on Schedule J, line 5. The farmer combines that amount with the \$6,000 on Schedule J, line 6, and enters \$6,000 on Schedule J, line 7.

Line 8

If line 7 is zero, enter -0- on line 8. Otherwise, figure the tax on the amount on line 7 using:

- The 2019 Tax Rate Schedules below;
- The 2019 Qualified Dividends and Capital Gain Tax Worksheet, later;
- The 2019 Schedule D Tax Worksheet in the 2019 Schedule D instructions (but use the 2019 Tax Rate Schedules below when figuring the tax on lines 34 and 36 of the Schedule D Tax Worksheet); or
- The 2019 Foreign Earned Income Tax Worksheet, later.

If your elected farm income includes net capital gain, you must use the 2019

Schedule D Tax Worksheet to figure the tax on the amount on line 7. However, if you filed Form 2555 for 2019, you must first complete the 2019 Foreign Earned Income Tax Worksheet, and then use the 2019 Schedule D Tax Worksheet to figure the tax on the amount on line 3 of

the Foreign Earned Income Tax Worksheet.

When completing the Schedule D Tax Worksheet, you must allocate 1/3 of the amount on Schedule J, line 2b (and 1/3 of the amount on line 2c, if any) to

2019. If for 2019 you had a capital loss that resulted in a capital loss carryover to 2020, don't reduce the elected farm income allocated to 2019 by any part of the carryover.

2019 Foreign Earned Income Tax Worksheet—Line 8



Use this worksheet if you claimed the foreign earned income exclusion or housing exclusion on your 2019 Form 1040 using Form 2555. However, if Schedule J, line 7, is zero or less, don't complete this worksheet. 1. Enter the amount from your 2022 Schedule J, line 7 2a. Enter the amount from your (and your spouse's, if filing jointly) 2019 Form 2555, lines 45 and b. Enter the total amount of any itemized deductions or exclusions you could not claim for 2019 c. Subtract line 2b from line 2a. If zero or less, enter -0-4. Figure the tax on the amount on line 3. Use the 2019 Tax Rate Schedules, the 2019 Qualified Dividends and Capital Gain Tax Worksheet,* or the 2019 Schedule D Tax Worksheet in the 2019 6. Subtract line 5 from line 4. Enter the result. If zero or less, enter -0-. Also include this amount on * Enter the amount from line 3 above on line 1 of the 2019 Qualified Dividends and Capital Gain Tax Worksheet or the 2019 Schedule D Tax Worksheet if you use either of those worksheets to figure the tax on line 4 above. Complete the rest of that worksheet through line 6 (line 10 if you use the Schedule D Tax Worksheet). Next, you must determine if you had a capital gain excess. To find out if you had a capital gain excess, subtract the amount from your 2022 Schedule J, line 7, from line 6 of your 2019 Qualified Dividends and Capital Gain Tax Worksheet (line 10 of your 2019 Schedule D Tax Worksheet). If the result is more than zero, that amount is your capital gain excess. If you didn't have a capital gain excess, complete the rest of either of those worksheets according to the worksheet's instructions. Then complete lines 5 and 6 above. If you had a capital gain excess, complete a second 2019 Qualified Dividends and Capital Gain Tax Worksheet or 2019 Schedule D Tax Worksheet (whichever applies) as instructed above but in its entirety and with the following additional modifications. Then complete lines 5 and 6 above. These modifications are to be made only for purposes of filling out the 2019 Foreign Earned Income Tax Worksheet above. 1. Reduce (but not below zero) the amount you would otherwise enter on line 3 of your 2019 Qualified Dividends and Capital Gain Tax Worksheet or line 9 of your 2019 Schedule D Tax Worksheet by your capital gain excess. 2. Reduce (but not below zero) the amount you would otherwise enter on line 2 of your 2019 Qualified Dividends and Capital Gain Tax Worksheet or line 6 of your 2019 Schedule D Tax Worksheet by any of your capital gain excess not used in (1) above.

- 3. Reduce (but not below zero) the amount on your 2019 Schedule D (Form 1040), line 18, by your capital gain excess.
- 4. Include your capital gain excess as a loss on line 16 of your 2019 Unrecaptured Section 1250 Gain Worksheet in the 2019 Instructions for Schedule D (Form 1040).

If you used Schedule J to figure your tax for:

- 2021 (that is, you entered the amount from the 2021 Schedule J, line 23, on your 2021 Form 1040, 1040-SR, or Form 1040-NR, line 16; or 2021 Form 1040-X, line 6), enter on line 9 the amount from your 2021 Schedule J, line 15; or
- 2020 but not 2021, enter on line 9 the amount from your 2020 Schedule J, line 3.

If you figured your tax for both 2020 and 2021 without using Schedule J, enter on line 9 the taxable income from your 2020 tax return (or as previously adjusted by the IRS or corrected on an amended return). But if that amount is zero or less, complete the worksheet below to figure the amount to enter on line 9.

If you didn't file a tax return for 2020, use the amount you would have reported as your taxable income had you been required to file a tax return. Be sure to keep all your records for 2020 until at least 3 years after April 18, 2023 (or the date you file your 2022 tax return, if later).

Instructions for 2020 Taxable Income Worksheet

Line 2. Any net capital loss deduction on your 2020 Schedule D, line 21, isn't allowed for income averaging purposes to the extent it didn't reduce your capital

loss carryover to 2021. This could happen if the taxable income—shown on your 2020 Form 1040, 1040-SR, or Form 1040-NR, line 15 (or as previously adjusted)—was less than zero. Enter on line 2 the amount by which your 2020 capital loss carryover to 2021 (the sum of your short- and long-term capital loss carryovers) exceeds the excess of the loss on your 2020 Schedule D, line 16, over the loss on your 2020 Schedule D, line 21. If you had any NOL carrybacks to 2020, be sure you refigured your 2020 capital loss carryover to 2021.

Line 3. If you had an NOL for 2020, enter the amount of that NOL from the 2020 Form 1045, Schedule A, line 24, you filed with Form 1045 or Form 1040-X. If you didn't have an NOL for 2020, enter the portion, if any, of the NOL carryovers and carrybacks to 2020 that weren't used in 2020 and were carried to years after 2020.

Example. The farmer didn't use income averaging for 2019, 2020, or 2021. The taxable income on the farmer's 2020 Form 1040, line 15, is a negative \$29,900. The deduction for exemptions has been suspended. The farmer subtracts from the \$29,900 loss the \$0 deduction for the suspended exemptions. The result is a negative \$29,900, the farmer's 2020 taxable income, which the farmer enters as a positive amount on line 1 of the 2020 Taxable Income Worksheet.

When the farmer filed their 2020 tax return, the farmer had a \$3,000 net capi-

tal loss deduction on Schedule D, line 21 (which was also entered on Form 1040, line 7), and a \$7,000 loss on Schedule D, line 16 (as adjusted). The farmer also had a \$7,000 capital loss carryover to 2021.

The farmer adds the \$3,000 from Schedule D, line 21, and the \$7,000 capital loss carryover. The farmer subtracts from the \$10,000 result the \$7,000 loss on the Schedule D, line 16, and enters \$3,000 on line 2 of the worksheet.

The farmer enters \$14,500 on line 3 of the worksheet, the 2020 NOL from their 2020 Form 1045, Schedule A, line 24. Of the \$29,900 negative taxable income, the \$0 deduction for the suspended exemptions, the \$3,000 capital loss deduction, and the farmer's \$12,400 standard deduction weren't allowed in figuring the NOL. The farmer had a \$14,500 loss on the 2020 Schedule F, the only other item on the farmer's 2020 tax return.

The farmer enters \$17,500 (the \$3,000 line 2 amount plus the \$14,700 line 3 amount) on line 4 and \$12,400 (the \$29,900 line 1 amount minus the \$17,500 line 4 amount) on line 5. The farmer enters \$12,400 as a negative amount on Schedule J, line 9. The farmer enters \$6,000 on Schedule J, line 10, and a negative \$6,200 on Schedule J to figure their tax for 2023, the farmer will enter the negative \$6,200 amount on their 2023 Schedule J as the farmer's 2020 taxable income for income averaging purposes.

Line 2. Any net capital loss deduction on your 2021 Schedule D, line 21, isn't allowed for income averaging purposes to the extent it didn't reduce your capital loss carryover to 2022. This could happen if the taxable income—shown on your 2021 Form 1040, 1040-SR, or 1040-NR, line 15 (or as previously adjusted)—would have been less than zero

if you could have entered a negative amount on that line. Enter on line 2 the amount by which your 2021 capital loss carryover to 2022 (the sum of your short- and long-term capital loss carryovers) exceeds the excess of the loss on your 2021 Schedule D, line 16, over the loss on your 2021 Schedule D, line 21.

Line 3. If you had an NOL for 2021, enter the amount of that NOL from the 2021 Form 1045, Schedule A, line 24, you filed with Form 1045 or Form 1040-X. If you didn't have an NOL for 2021, enter the portion, if any, of the NOL carryovers and carrybacks to 2021 that weren't used in 2021 and were carried to years after 2021.

Example. The farmer didn't use income averaging for 2019, 2020, or 2021. The taxable income on the farmer's 2021 Form 1040, line 15, would have been a negative \$1,000 if the farmer could have entered a negative number on that line. This amount includes an NOL deduction on the farmer's 2021 Schedule 1 (Form 1040), line 8a, of \$5,150. The \$5,150 is the portion of the 2020 NOL that was remaining from 2019 to be carried to 2021. See the examples earlier. The farmer's taxable income is limited to zero and the farmer doesn't have an NOL for 2021. The result is a negative \$1,000, the farmer's 2021 taxable income, which the farmer enters as a positive amount on line 1 of the 2021 Taxable Income Worksheet.

When the farmer filed the 2021 tax return, the farmer had a \$3,000 net capi-

tal loss deduction on Schedule D, line 21 (which was also entered on Form 1040, line 7); a \$7,000 loss on Schedule D, line 16; and a \$5,000 capital loss carryover to 2022 (the farmer's 2021 capital loss carryover to 2022 was \$5,000, not \$4,000, because the amount on the Form 1040, line 15, would have been a negative \$1,000 if the farmer could have entered a negative number on that line). The farmer adds the \$3,000 from Schedule D, line 21, and the \$5,000 carryover. The farmer subtracts from the \$8,000 result the \$7,000 loss on the Schedule D, line 16, and enters \$1,000 on line 2 of the worksheet.

The farmer enters -0- on line 3 of the worksheet because the farmer doesn't have an NOL for 2021 and didn't have an NOL carryover from 2021 available to carry to 2022 and later years. The NOL deduction for 2021 of \$5,150 was reduced to zero because it didn't exceed the farmer's modified taxable income of \$7,150. Modified taxable income is figured by adding back the \$3,000 net capital loss deduction to taxable income (figured without regard to the NOL deduction) of \$4,150. The farmer enters \$1,000 on line 4 and \$0 on line 5 of the worksheet. The farmer enters \$0 on Schedule J, line 13. The farmer enters \$6,000 on Schedule J, line 14, and \$6,000 on Schedule J, line 15. If the farmer uses Schedule J to figure the farmer's tax for 2023, the farmer will enter \$6,000 on the farmer's 2023 Schedule J as the 2021 taxable income for income averaging purposes.
